



Licensing conditions for the use of geographic information products and services produced by the IGN and for those co-produced by the Autonomous Regions and the Association of Spanish Geographers (AGE) within the framework of the National Cartographic System

This license establishes the conditions of use and access to geographic information products and services generated by the General Directorate of the National Geographic Institute of Spain, hereinafter IGN, under the Ministry of Development. Said conditions comply with the provisions of Ministerial [Order FOM/2807/2015](#), of December 18, 2015, BOE 2015.12.26, which amends Ministerial Order FOM/956/2008 dated March 31, BOE 2008.04.08.

As stated in the aforementioned Ministerial Order FOM/2807/2015, Article 4: "The use of the digital geographic information products mentioned in Article 2 will be open and free of charge, provided that the origin and ownership of the data is mentioned, within the scope and in the way authorized by the corresponding license".

Therefore, the use of the IGN's geographic information products and services defined within the scope of Order FOM/2807/2015 implies the user's acceptance of a [CC-BY 4.0](#) license, as defined in:

Where attribution shall be made as follows:

1. For products, in those cases in which the original digital geographic information is not modified or altered, the following general expression must be used: "<product identifier> <date> CC-BY 4.0 <attribution of producer>", in which the tags <product identifier>, <date> and <attribution of producer> will be replaced by the corresponding values of the table of products, which can be found on the website published for this purpose:

This mandatory attribution notice must be displayed in a visible manner along with the data, legibly and at the foot of the map, image, presentation or viewing window. In the event of manifest and justifiable impossibility, it may be included in lists of layers or services, legends, tables of contents or credits, in such a way that the origin and ownership by Spain's IGN is always clear.

2. For services, in those cases in which the service is used unmodified, the attribution notice to be used shall be the one established for the coupled data used in each case and, if there is no coupled data, then the formula included in the self-description of the original service, in the <AccessConstraints> tag.
3. The following recitals are applicable:
 - One.- The <date> can be a range of dates as indicated in the table of products.
 - Two.- To complete the attribution of the producer <attribution of producer>, the following may be used: the website address, the generic name of the group of producers or any of its variants (variant 1, variant 2 ...) listed on the table of products published on the mentioned website. In any case, whenever feasible, the text will include a hyperlink to the corresponding website.
 - Three.- For products generated collaboratively by the IGN and the Autonomous Regions and those services coupled thereto, if using any of the variants, and if it is a territorial area completely contained within an Autonomous Region, the formula under variant 2 shall be preferably used, without mentioning any of the other Autonomous Regions.
 - Four.- The general expression "CC-BY 4.0 <attribution of producer> <date>" may be used as an abbreviated alternative formula and for justifiable reasons of space or design.

As in:

4. If the licensed user generates a work derived from one or more of the IGN's products and data services, "Work derived from" must be added before the general expression, thereby resulting in "Work derived from <product identifier> <date> CC- BY 4.0 <attribution of producer>", and the recitals indicated above will continue to apply.

As in:

Work derived from PNOA 2010-2013 CC-BY scne.es

5. If the user generates a new set of data by modifying the original IGN data, the licensee must, in addition to the attribution through the expressions described above, also include such expressions in the metadata, if any, specifically in the following metadata elements or equivalents: *abstract*, *lineage* and *AccessConstraints*.
6. If the user generates a new web service, by modifying the coupled set of data or the original service, the licensee must also incorporate those attribution expressions described above into the self-description of the service (*GetCapabilities* or similar) and in any



metadata the service may have, specifically in the *otherConstraints* metadata element (free text), in the *Abstract* or equivalents.

7. In exceptional cases, for justified reasons and prior notification to the CNIG, the parties may agree on alternative attribution mechanisms. The user may use IGN's geographic information products and services, with express authorization, without an accompanying visible mention and without citing the origin and ownership by the IGN.

This definition of License has been approved by the President of the CNIG in exercise of the implementing powers conferred upon him by Ministerial Order FOM/2807/2015, which authorizes him to resolve as many questions of a general nature as may arise in its interpretation, according to the First Final Provision of said Ministerial Order FOM/2807/2015.
